# Welcome from Ciarán



Welcome to our **32nd edition** of The Village News!

**Calling on all Members, Residents, Residents' Families, Staff!  
It's time to contact your State and Federal MP and local Councillor!!**

I have used this article on many occasions in the past to call on you to place on the agenda of your local Member of Parliament the issue of Caring for our Older People. I am now asking for you to do so again and to do it soon! Don't wait for an Election (and we will be having a Federal one in the next 12 months).

Getting older affects us all. Let me say that again and louder, **Getting Older Affects Us All!** And it's getting a lot more expensive and challenging to provide the standards of care and accommodation that we expect across Australia to be delivered in our residential aged care facilities (RACF) and in our Retirement Villages (RV). It is practically impossible for many Operators to do so in a sustainable manner in a person's own home through a program of Home Care Packages. My admiration to those Operators of Level 1, 2, 3 and 4 providing home care to very dependent older people who get by on a few hours of care and assistance each week. And "get by" is an appropriate description.

We all welcomed Government policy to 'maintain older people in their own homes' when first introduced some years ago. Who would not want to spend more time in your own home? However, ask any Director of Nursing or Care, any Care Staff, any member of the Aged Care Assessment Team and any Provider or Operator of a residential aged care facility and they will openly share with you the demonstrated anecdotal evidence that they see every day, that the policy to keep older people at home longer has served singularly to contribute to people seeking places at residential aged care facilities when they are in states of increased frailty, disability, diminished independence and poor mental health. Is it hardly surprising that the average period of stay in a residential aged care facility is now between 18-24 months? And interestingly, this is a timeline that Treasury appear to have geared their financial policies in Aged Care also to!

Is this what Australia really wants? Is this what older people want? Is this what you want?

In previous years, older people entered what was prior to the Living Longer, Living Better changes introduced by the Federal Government in 2013 and 2014, a low care hostel with 'ageing in place' or a high care nursing home. Since the Aged Care Reforms after 1 July, 2014, these descriptions are essentially historical.

We are now known as Residential Aged Care Facilities and wait for it, subsidised by the Government Department to provide care to residents with increasingly higher levels of care. And the financial support that we may claim through the Medicare Payments system (the Aged Care Funding Instrument or ACFI) is geared to compensating Operators least for the lowest assessable forms of care and greatest for those residents requiring higher care. This is logical, it's rational, it makes sense and it's rationing essential services so that the Government or more precisely, the taxpayer, only needs to pay for those older persons who really need those higher forms of care. But that's not really the whole story. Read on!

Now, let me be clear, this is not a whinge!

Far from it. I appreciate fully the delicate balance that must be achieved in any business between revenue and expenditure, the pressure to achieve surplus or profit and avoid loss. No-one steps in to support us if we are struggling as a business. We don't have shareholders to seek capital from when we are considering growth, expansion or funds for renovations.

We must plan our finances extremely well and when we need additional cash, we need to speak to the Banks. Our Annual Report 2014-2015 demonstrates that we have been managing our finances very well to date. But we can never be complacent. We need to budget well, control our expenses robustly and we need to maximise our income streams. And we need for residents, their families, current and future to understand all of this too.

The Government has made it very clear to Operators and Providers of Retirement Villages over the years. **They provide zero support to us!** We are on our own!

The Government has interfered in business practices of our residential aged care facilities and in laissez-faire economics by dictating every financial element of how fees are charged to residents. They even made it harder when on 1 July 2014, they removed the ability of Operators of residential aged care facilities to keep retentions on resident accommodation bonds for any resident entering a residential aged care facility after that date, the maximum amount that could be kept previously was under \$20,000 over a maximum five year period. And they interfered by placing controls and restrictions on the level of Accommodation Payment (previously known as an Accommodation Bond) to \$550,000.

And to ensure that such control was intact, they created a whole new bureaucracy called the Aged Care Commission to whom Operators need to apply in an onerous application form process providing evidence as to why the Accommodation Payment should be greater than \$550,000. Is this really the business of the Government? Well, it certainly is if we are in a centralised form of governing, lacking in business acumen, enterprise or experience!

I prefer to think that it's more about ill-informed politicians who are taking inadequate and incorrect advice from self-interested parties and from Departmental public servants in their very protected jobs, and who never have to be accountable for their decisions, with inability to achieve targets or timelines and who never have to consider how their inefficiencies affect the rest of us in so many ways. **Don't we pay their wages? Should we be reminding them of this? And shouldn't we be telling our politicians that we elect them to represent us, to get the job done and to manage their Departments and our public servants?**

And did you know that the rationing of places in Residential Aged Care Facilities remains firmly in the hands of the Department of Social Service's office controlling the annual exercise called the Aged Care Approvals Round or ACAR. Believe it or not, Operators and Providers of residential aged care facilities have to apply for additional places – a process of approximately 15,000 words answering ridiculous questions. Ridiculous and insulting if you are operating a successful residential aged care facility such as, "How will you provide care to older persons?"

The Department's own regulatory bureaucracy and onerous audit process required Operators to achieve 44 outcomes (not 43 or 42 or 41, but all 44 outcomes) in every aspect of our operations to achieve a licence to practice and operate a residential aged care facility every three years and they inspect and audit us twice yearly, once announced and once unannounced.

We are required to furnish the Department with our annual financial report, to demonstrate our prudential compliance with accommodation bonds and payments and to complete multiple returns throughout the year. They also audit annually our ACFI Medicare Payments to ensure our compliance and honesty. And with all of this information, they still require us to engage in a rigorous exercise to ask for additional places to meet the current and future demand.

Now, many people appreciate that there are insufficient residential aged care places currently available to meet demand.

In 2014, I read a report circulated in the industry indicating that hundreds of places in residential aged care facilities are needed to be built every month over the next seven years to keep pace with national population increases (that was in 2014). It takes on average three years from first decision to build, engagement of architects and contractors, development planning and consent, financing, building, certification and staff recruitment before turnkey and welcoming residents to their new home. Three years! And it currently takes Department staff at least six months (it was previously between 12-18 months) to process the ACAR application from a forward thinking Operator who wants to provide a supply of places to meet current and future demand. So, a potential three and a half year process to open a new additional residential aged care place. It will take longer if the residential aged care place is on Crown Land because as the 'Owner' they must also look at the Development Application before it goes to the local Council Authority and their timeline at Crown Lands for a simple signature of consent is weeks to months!

I am confident that I and many of my colleagues in the industry could cut 12-18 months off this process by streamlining Departmental involvement at Federal and State levels as well as from within local Councils.

**And unless we all start realising that this is needed and to tell our politicians so, we will never achieve the services needed today, tomorrow, in 5 years, 10 years or in 20 years! And I have not even mentioned in this article the epidemic of Dementia that faces us in only a few years time!**

Let me share a few facts with you to paint the picture a little clearer:

- The Australian population over 75 is expected to grow from 1.5 million in 2014 to 4.3 million in 2050
- Industry needs to grow from 190,000 RACF places to 259,000 places by 2022 to meet demand
- Over 8.1 million Australians will be over 65 by 2050
- 184,000 live in retirement villages or 5.7% of the over 65 population (Property Council of Australia, October, 2014)

- The Penetration Rate is expected to rise to 7.5% in 2025, 328,000 people are expected to want to live in a RV in 2025
- Significant investment needed to achieve future demand
- RV sector supplies specially designed homes, preventative healthcare and community services often at much lower margins than other property assets competing for capital
- RVs are a self-funded service, receiving no government funding or subsidies
- RVs range of supports & services generate savings to Governments, \$2.16 billion to the health care system of which \$1.98 billion are achieved by RVs delaying residents entry to Government funded RACFs
- There is a potential \$177 million saved through RV residents requiring fewer hospital and GP visits, earlier discharge from hospital and better mental health
- As well as generating savings, the RV sector contributes to GDP \$2.93 billion (October 2014) and taxation revenue of \$176 million through investment and village operations
- The RV sector employs 19,000 people
- The Alzheimer Disease International (ADI) World Alzheimer Report 2015 calculated that the global cost of dementia has increased from \$604 billion in 2010 to \$818 billion in 2015, a rise of 35% in total cost
- ADI noted that "if dementia were its own Country, it would be the 18<sup>th</sup> largest economy in the world and would exceed the market values of Companies such as Apple (US\$742 billion) and Google (US\$368 billion)"
- Dementia is growing at epidemic proportions
- Alzheimers Australia reported in 2015 that there are 340,000 Australians with dementia
- 1,800 Australians are diagnosed with dementia each week which approximates to 1 person every 6 minutes (Alzheimers Australia, 2015)
- 900,000 to be diagnosed by 2050 (Alzheimers Australia, 2015)

## Get the Picture!

I really hope that this article has been informative and motivates you to contact your State and Federal Representative. I would suggest you contact your local Councillor too because of the building planning powers of Councils. We are going to need to work together to make the changes that we need locally and across Australia to provide the quality care and accommodation as well as appropriate funding balance that we need and want for our Older Persons. Let's Make a Real Difference! Let's Make the Change!

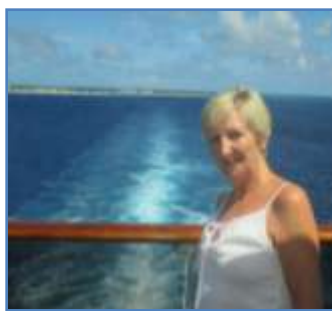
